## Seven Oaks Closes Construction Financing for 2135 American Industrial Way in Chamblee, GA Patterson Arranges Joint Venture Partnership with Packard Capital

**Chamblee, GA:** Seven Oaks Company, LLC in a joint venture with Packard Capital, LLC has begun redevelopment of 2135 American Industrial Way in Downtown Chamblee. The single-story, 35,500 square foot building historically served as a warehouse for an event table and chair rental company and an antique showroom that provided movie props to local film studios. Seven Oaks has engaged Winter Construction Company as general contractor to completely renovate the 2-acre site and building into creative office space, S/L/A/M Collaborative as architect designed the building, and Kimley Horn & Associates completed the civil and engineering design work.

The building will feature ample outdoor work and social areas including a 1,200 square foot covered front patio, an additional outdoor beer garden-style seating area, and a dedicated food truck parking place. The interior of the building will feature a furnished and finished lobby and break area with roll-up garage doors leading onto the front patio, large façade windows, ability to add exterior access points for direct tenant access to supplement the base building common corridor, and the option to modify windows to allow for open / close function.

Randy Holmes, Principal of Seven Oaks Company, indicated Seven Oaks has been working on unlocking the building for several years. "We're excited to be part of the growing and vibrant Downtown Chamblee community that has been gaining momentum with other commercial and residential developments. 2135 will appeal to businesses that desire walkability to nearby amenities including restaurants such as Southbound and BlueTop along with convenient access to nearby diverse neighborhoods, arterial roadways, and MARTA," said Randy Holmes.

Construction is underway and the building is scheduled to deliver in June 2022. Aileen Almassy and Andy Sumlin with Cushman & Wakefield are representing ownership.

"Chamblee has experienced a ton of momentum in the last several years, so we're looking forward to watching the Property's success over time.
